- **15. Highways Issues (hedges, footpaths etc)** If an issue needs reporting then Councillors must provide a full location address including postcode.
- a) Cllr Hulme advised that yes the Tumulus should be seen at all times but the hedge can only be trimmed from September to February as per DEFRA regulations. Clerk will advise relevant resident.
- b) It was brought up that residents have complained about the number of dog foul bags being placed in the hedge between houses and cemetery on Hollington Road. Proposal made to write to SMDC Street Scene (SMO/2019/007) and request if they could investigate placing an additional bin.
